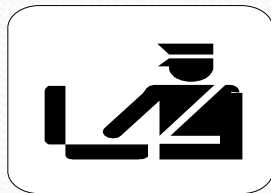

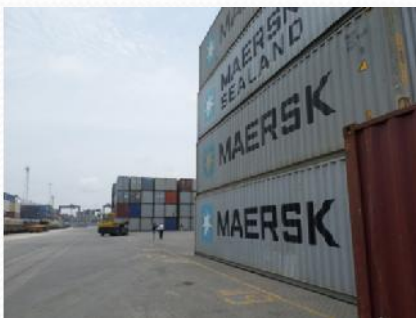
## Transportation Assets

## **TAT for Local Import Shipments : 4 / 5 working days**

- Day '0' : Receipt of advance shipment documents, preparation for Shipment Entry, Get Pre Assessment by Customs.
- Day '1' : Landing of container at Port / CFS, Filing of Shipment Entry in custom.
- Day '2' : Pay dues to Carrier Agent and get Delivery Order, Assessment of Bill of Entry.
- Day '3' : Confirmation of customs duty / Exemption, Move Container to inspection area.
- Day '4' : Inspection of container by Customs at port /CFS & Get Release Order, Pay dues to Port/CFS.
- Day '5' : Movement of container to Consignee Facility after obtaining Gate Pass from Customs and Port / CFS authorities.





## **TAT for Transit Import Shipments : 4 / 5 working days**

Day '0' : Receipt of advance shipment documents, preparation for Shipment Entry

Day '1' : Landing of container at Port / CFS,  
Filing of Shipment Entry in custom.

Day '2' : Pay dues to Carrier Agent and get Delivery Order,  
Assessment of Bill of Entry for Transit.

Day '3' : By Customs assessment & Inspection at port /CFS to Get Release Order,  
Request to move Container to Loading area.

Day'4' : Pay dues to Port/CFS.

Day '5' : Loading of FCL containers / Stripping containers and loading on trucks and  
Movement of Trucks to Consignee Facility after obtaining gate pass from  
Customs and Port / CFS authorities to the final Destination.



## **TAT for Transit Export Shipments : 4 / 5 working days**

Day '0' : Loading from Origin, Transport and clearance at Tanzania Border Entry.  
Get Shipping Instruction from Customer for the Export.

Day '1' : Booking with Carriers and get empty containers available at Yard Place.

Day '2' : Entering Truck at Yard. Inspection, Sampling, Weighing & Stuffing the cargo in to the Containers.

Day '3' : Submit Documents to custom and get Release Order.

Day '4' : Pay dues to Port and Get Export Order (Container Transfer Permit).

Day '5' : Shifting the Containers from Yard to Port Gate.

When Vessel Sail to follow for the BL.
